A leak was reported on Rte 28A, a leak on Butler Road was called in on Saturday, and a leaking meter was called in on Sunday at Verna Lane and a call from 41 Rand Hill Rd., meter froze and broke.

One abatement was signed.

F. OLD BUSINESS: Loam is to be taken to Burwell/Stanley and Pasquariella to clean up work area from last fall. Pasquariella also to have cold patch for the driveway where it was damaged.

G. NEW BUSINESS: 230' of line was replaced on Rte 28A. A line needs to be put in at Monument Square. RPZ's (reduced pressure zone) are needed at the Alton Central Fire Station, the Highway garage, and the public restroom at the bay on the west side.
