# Alton Conservation Commission Approved by the Conservation Commission 5-24-07 Minutes of May 10, 2007

# **Call Meeting to Order:**

Co-Chairman E. Bagley called the meeting to order at 7:05 p.m.

#### **Approval of Agenda:**

Motion made by D. Lawrence and seconded by G. Young to amend the agenda and include under to include under Commissioner Reports – D. Lawrence Warrant Articles for 2008 and to include under Correspondence – E-mail letter Re: Dobbins Brook (Finnegan Subdivision) and Archaeological Survey for Map 9 Lot 53 Prospect Mountain Builders. The motion passed with all in favor.

Motion made by D. Lawrence to accept the minutes with changes second by R. Burgess. The motion passed with all in favor.

# **Standard Dredge and Fill Applications:**

1. Benjamin Finnegan Map 6 Lot 37 – Request to impact a total of 9,031 sq. ft. of wetlands to access upland areas and construct a subdivision road and driveways associated with residential development for this proposed 15-Lot subdivision.

Present for the site walk: Earl Bagley, Justine Gengras, Gene Young, David Lawrence, and Tom Hoopes for the Conservation Commission as well as the Planning Board. Also present were Cindy Balcius and Adam Doiron from New Hampshire Soils.

T. Hoopes stepped down.

The Commission had a site walk on May 10, 2007 at 5pm on the property. They feel that the culverts are too small for impacts 4 & 5 due to the width of bank overflow and wetlands associated with the streams. They also viewed impacts 1, 3, 6, & 7.

J. Gengras asked about detention ponds. Adam Doiron responded with that they are going to handle run-off with swales and not detention ponds.

J. Gengras also feels that the amount of old timber slash/logs lying in the wetlands associated with the logging road that leaves Valley Road, south of impact #6, diminishes the function of the wetlands. In addition a huge, broad area east of and abutting the current culvert in the perennial stream exhibited a water-scoured surface. It appeared that a new culvert and stone fill has recently been placed in the perennial stream for the logging road. No siltation or erosion controls were present. A nearby tributary for the main stream exhibited significant erosion where a 12" culvert failed.

In reference to the e-mail from Anthony Tur an Endangered Species Biologist to New Hampshire Soils who found no small whorled pogonia at the site, the Commission noted that the absence of the small whorled pogonia would be expected, given that the inspection was conducted at a time of year when the plant has not even emerged.

Since Alton has experienced two 100-year storms in the last year, the Planning Board should impose a requirement for larger culverts than are presently specified for the project. Several lots have upland areas separated by wetlands, making it likely that the owners will put fill in the wetlands to facilitate access. Explicit restrictions should be imposed to prevent damage to

Motion made by J. Gengras to continue until the next meeting and designate J. Gengras to bring in a draft comment for review by the Commission at the next meeting, seconded by G. Young. Motion passed with all in favor.

2. Greg Vickowski map 42 Lot 12 – Remove 71' of existing mortar rubble masonry wall to high water mark and re-establish with rough cut stones landward of the reference line. Stabilize 12.5' of eroded bank, place stones in ledge cavity of 8' of shoreline.

#### **Discussion:**

The Commission reviewed the application and feels that a letter of no objection should be sent to NH DES with comments.

Motion made by J. Gengras to send a standard letter of no objection to NH DES with the following comments attached: The Commission does not object to the proposed project providing there is a condition that the proposed drainage swale behind the wall doesn't divert water onto the abutting property and create ay adverse affects on the abutter and that the work should be done after draw down and not during full lake level, seconded by E. Bagley. Motion passed with all in favor.

- 1. Cindy Walker Map 44 Lot 55 Repair an existing, permitted, piling supported dock and accessory structures "in-kind" with no change in size, location, or configuration, install a seasonal boatlift and two seasonal PWC lifts. FYI Commission signed 5/4/07
- 2. Elaine Milnor Map 59 Lot 12 Replace 10 piling on existing structure. Impact 10 Sq. ft. FYI Commission signed 5/9/07.

- 2. Ronald Cima Map 21 Lot 30 The proposed project involves the placement of one 57"x38"x20' pipe arch (squash culvert) in a seasonal stream to provide driveway access to an existing home. The amount of wetlands to be disturbed is 1280 sq. ft.
