#### I. CALL TO ORDER

#### III. ZONING AMENDMENT S

K. McWillliams gave an overview of the purpose for this meeting. This is in advance of the formal Public Hearings. There are two Public Hearings scheduled in January. The first one will be held on January 10, 2012. Depending on what happens at that Hearing there is an opportunity for a second Hearing on January 31, 2012 if needed. To clarify the process both tonight and the January 10<sup>th</sup> meeting the Planning Board has the opportunity to make changes to the amendments. On the last Public Hearing in January they can make editorial changes but no substantive changes so at that point it is a vote up or down to take that amendment to the ballot vote at March Town Meeting.

Carol Locke, 17 Prospect Mountain Road, spoke regarding the Function Facility Amendment. She asked how they were going to prevent concert venues. Because of the language it is difficult to determine if concert venues are accepted or not.

S. Williams stated that concerts for pay would not fall under that category.

D. Hussey stated for a concert they would have to get a permit from the Selectmen and the abutters would be notified.

She also asked why Lakeshore Residential was not included as an exception.

K. McWilliams explained that that area is the most restrictive district zone in Town so that is the most protective district and it is definitely a residential area. He stated that he would amend the definition of a Commercial Function Facility to state that concert venues would not be included in the definition.
