The Applicant shall be responsible for maintaining access to the subject property and shall hereby forever release and discharge the Town, its officers, agents, and employees, from the obligation of maintaining access to said Island, and from any claim of any nature, whether in tort or otherwise, which the Applicant might have against the Town for any loss or damage, including those incurred through failure to provide any municipal service including police, fire, and ambulance services, arising out of the condition of said Island access; and,
