On behalf of Joseph Byrne, Brad Jones, Jones & Beach Engineers, Inc., is requesting a one year time extension from the expiration of the last approved extension due to expire on March 21, 2013.

K. Williams explained the reason for there extension. They are asking for an extension to 2014. They want to recommence construction this spring. They have two more conditions of approval to satisfy. One is to get the Certificate of Organization of the Home Owners Association filed with the NH Secretary of States Office and providing a certificate of proof of that filing to the Planning Department. Second is providing security for the reclamation plan that has been previously approved. That amount would be \$26,134.00. He recommends the Board approve the 12 month extension to 2014.

Brad Jones with Jones & Beach Engineers spoke on behalf of the applicant. They want to have a preconstruction meeting on April 15th. The applicant is aware of the conditions and the Homeowner documents are done. They need to be recorded. All permits are current.
