## Minutes of March 26, 2009 Meeting

## **Members Present:**

#### **Call Meeting to Order:**

Chairman Earl Bagley called the meeting to order at 7:25 p.m. at the Alton Town Hall.

#### **Approval of Agenda**:

E. Bagley suggested moving #4 of Other Business to the beginning of the Agenda.

Motion made by D. Lawrence to accept the Agenda as amended, seconded by G. Young.

The motion passed with all in favor.

# Approval of Minutes of March 12, 2009:

Motion made by D. Lawrence to accept the Minutes as stated, seconded by J. Gengras. The motion passed with all in favor.

#### **Presentations/Consultations:**

1. <u>Brad Hunter of Baywinds/Wentworth Cove</u> – Conservation Easement Deed. Brad has been working on the permitting for this sub-division since 2003 and it is getting close to completion. The piece of the puzzle is to put forward a wetlands mitigation plan as required by the NHDES Wetlands Bureau. He found a parcel of land for a conservation easement that is acceptable to NHDES and the Conservation Commission. It is near the Gilman Pond conservation land. B. Hunter provided the Commission with a draft conservation easement deed.

## **Discussion:**

The proposed conservation easement parcel abuts the east side of the 36 acre conservation lot in the Norby Ridgewood subdivision and is about 300 ft. west of town-owned conservation parcel Map 15, Lot 53. This easement lot would add a link of protected land to the un-fragmented forested corridor between Gilman Pond and Hurd Brook.

The Commission noted that the draft deed is incomplete and requires corrections. The Conservation Easement Deed presented did not have an Exhibit A attached to it. In addition the language in the deed refers to two plats, but only one plat is recorded. The recorded plat does not show the conservation easement. The Deed and plat references need correction. The Conservation Commission cannot accept the deed as it is written. B. Hunter will consult with his attorney regarding corrections. The Commission will review the deed again after corrections are made.

## Planning Board/ZBA Agenda Items:

 Catherine & Matthew Bell – Dept. Head Review Request, Map 34, Lot 33, 75 Mount Major Highway, "Special Exception", Allow for the expansion of a non-conforming structure. <u>Discussion:</u>

The Commission reviewed the Special Exception Request and finds the project makes the non-conforming structure more non-conforming. Also the Shoreland section of NHDES regards the Alton Bay Christian Conference Center as one large lot with many structures; therefore changes to any structure are a very complex permitting problem. The Commission has recently received a copy of the NHDES correspondence stating that at this time no approvals will be issued for Alton

Bay Christian Conference Center properties until the outstanding compliance issues with DES are resolved.

2. <u>Cynthia Balcius & Jill Royer</u> – Dept. Head Review Request, Map 3, Lot 4, Prospect Mountain Rd., Site Plan of an existing barn converted to a consulting business. **F.Y.I Commission signed on 3/23/09.**
