He would like to get quotes on both the 3500 and the 5500 and the dump body is running about \$11,000.00. 3500 is around \$29,000.
- H. NEW BUSINESS: Water Billing and revenues were discussed.

Backflow Testing – Proposals – Some are done twice a year and some once a year depending on the type of business. We will pay for the testing and then bill our customers. Discussion was held on the quotes received.

Projects: 28-A: One section was done on 4/9/18 with flaggers from the fire department. Meters are to be installed for summer lines to document the water usage.
