Permit by Notification:

1. **Paul & Doreen Gabriellini** – Map 41, Lot 49. 69 Sawmill Brook Road. Repair/replace two cribs one 5'6" x 15'6" and on 7'x3" x 37 wetlands impact approx. 353 sq. ft. **(Commission signed on 4/29/2013).**

Commission reviewed with no comments or concern.

2. **Andrew & Victoria Freeston** – Map 79, Lot 2. 706 Rattlesnake Island. New seasonal, winch-out 6' 40' aluminum frame dock to be constructed next to existing 16' x 4' seasonal dock. Location is on the "broads side" of Rattlesnake Island.

Commission signed but with a question. Question on frontage, whether they are allowed this additional dock on 125 ft.

Minimum Impact Expedited:

1. **Samuel Cavallaro** – Map 73, Lot 30. 390 Sleeper Island. Permanently remove a 8'x23'6 dock along shore, Replace with a 4'x28' seasonal lift-out attached to shoreline rocks. Dock to be removed = 188 sq. ft. New seasonal dock 125 sq. ft. a reduction of impact approx. 53 sq. ft. **(Commission signed on 5/13/2013).**

1. **D. Lawrence regarding Town Forest and New Wetland Trail Development Activity.**
 - a. No Hunting signs have been taken down at the Town Forest. Was assisted by several citizens. Trails are in good shape. Bob Doyle offered to help work on trails.
 - b. Possible new trail walkway on wetlands across church (Drexel) on Route 28. We will meet with Kelly Troendle and Rick McDuff next week on plans. Discussed possible funding for materials for the walkway but did not commit to an amount at this time. This walkway goes over the wetlands. Discussion that the Commission would like to see plans or sketch. This walkway could conceivably go to the peninsula.
