Repair/Rebuild existing rock breakwater and 4' x 73' (+/-) cantilevered dockage "in-kind" in the same size, location and configuration. An extension to this structure was approved under NHDES Wetlands Permit #1992-00564 (John Bridges). As work occurs within the setback area, an Abutter's Notarized Consent Letter is enclosed.
